1. PRESIDENTIAL INTRODUCTION

We are now into the fifth month of the all-important process of working towards achieving the Sustainable Development Goals, with all actors well aware that the end timeframe of 2030 is not a distant goal but a challenge today and every day.

I was struck by a pithy phrase coming from the NGO community:
A DIFFERENT WORLD CANNOT BE BUILT BY INDIFFERENT PEOPLE !

How well that captures the spirit of NGOs and Civil Society Organizations. By their ethos NGOs and CSOs are not – and cannot be – indifferent to poverty, to hunger, to ill health, to ignorance, to gender inequality, to water and sanitation deficiencies, to polluting energy supplies, to ignoble working conditions, to global inequalities, to unsafe cities, to unsustainable production and consumption practices, to denial of climate change, to threats to marine life, to soil degradation and desertification, to injustice and corrupt governance, to turning one's back to one's neighbour.

This litany of course paraphrases the 17 SDGs and highlights the vastness of the challenges facing intergovernmental institutions, governments at all levels, civil society, academia, business, and indeed all citizens in all regions. The SDGs embody a pact between developing and developed countries that all will take timely and adequate domestic action to lead to achieving global sustainability. Domestic action needs the involvement and imaginative interventions of citizens, largely acting through NGOs and CSOs. To achieve the SDGs – as well of course as to augment democracy, fundamental freedoms and the rule of law – Governments must foster domestically an open and enabling environment for civil society organizations. This demands the immediate abandonment of the harassment and restrictive legislation introduced recently by too many governments around the world, and which has targeted NGOs, CSOs, human rights lawyers, indigenous community leaders, environmental whistle-blowers, the media, and more. Governments which do not trust their citizens must not be surprised when their citizens in turn do not trust them!

The underlying message of the SDGs is essentially that to achieve “The World We Want” – better still, “The World We Need” – requires unprecedented levels of partnership, cooperation, confidence, sharing of ideas and experience, transparency, accountability and good governance. The time to act is Today.

2. HABITAT III

CALL FOR HABITAT III SIDE & NETWORKING EVENTS

National, regional, and local governments, as well as representatives from civil society organisations, parliamentarians, research and academia, grassroots organisations, women's groups, children's and youth groups, business and industries, foundations and philanthropies, professionals, trade unions and workers, farmers, indigenous people, media, older persons, and intergovernmental organisations are invited to apply for organizing side and networking events at the Habitat III Conference taking place from 17 to 20 October 2016, in Quito, Ecuador. Deadline for applications is 30 May 2016.

SIDE EVENTS

With duration of one hour each, side events provide a platform to present research and data, projects, initiatives, or networks, signing of agreements, book launches, etc. on specific topics of relevance and interest within housing and sustainable urban development. Side events focusing on implementation and action-oriented initiatives for the New Urban Agenda will be prioritised.

NETWORKING EVENTS

Networking events provide a platform to discuss specific topics of relevance and interest within housing and sustainable urban development. Networking events have a duration of two hours and are an opportunity to build knowledge and strengthen partnerships and networks through sharing ideas and identifying best practices in an effort to advance sustainable urban development in cities and towns around the globe.

3. HABITAT III Open-ended Informal Consultative Meetings 25-29 April 2016, UN Headquarters, New York

The HABITAT III Open-Ended Informal Consultative Meetings brought together over 500 participants from civil society, academia, international organizations and governments. The meeting was organized around daily themes on: regional perspectives; transformative commitments for sustainable urban development; effective implementation; and how to enhance means of implementation (MOI).

Panels took place to examine the recommendations and outputs of the ten HABITAT III Policy Units on: the right to the city and cities for all; socio-cultural urban framework; national urban policies; urban governance, capacity and institutional development; municipal finance and local fiscal systems; urban spatial strategies, land market and segregation; urban economic development strategies; urban ecology and resilience; urban services and technology; and housing policies.

Panels were also organized around the outcomes of seven HABITAT III thematic meetings on: civic engagement; metropolitan areas; intermediate cities; sustainable energy and cities; financing urban development; public spaces; and informal settlements. One session also captured

outcomes of HABITAT III regional meetings, namely Asia-Pacific, Africa, Europe and Latin America and the Caribbean.

HABITAT III Secretary-General Joan Clos underscored the importance of multi-stakeholder inputs to the zero draft of the Habitat III outcome. He also outlined the work of over 200 experts in the ten Policy Units, which illustrate a step forward in the participatory nature of HABITAT III. He underscored that the New Urban Agenda should be complementary to recent landmark UN processes, including the : Sendai Framework for DRR 2015-2030; Third International Financing for Development Conference; 2030 Agenda on Sustainable Development; and Paris Climate Agreement.
